## CONSIGNMENT CONTRACT

Thank you for consigning with us!  
We look forward to building a relationship with you!

- \* Consignor (that's you) will receive 40% of the total selling price before taxes for items \$199 or less.  
Consignor (that's you) will receive 50% of the total selling price before taxes for items \$200 thru \$749.  
Consignor (that's you) will receive 60% of the total selling price before taxes for items \$750 and above.  
Consignor (that's you) will receive 50% of the total selling price before taxes for formals and cocktails.
- \* Markdowns and discounts will be shared equally between Back On The Rack and the consignor. A handling fee will be added to the price of each item to cover merchandise processing. This fee is passed on to the buyer and not split with Consignor. Occasionally, Back On The Rack will promote sales events & coupons to attract customers and move merchandise.
- \* The consignment period is 60 days (your items will be available for sale in our showroom for 60 days). Unsold items must be picked up within 10 days after they expire or they become property of Back On The Rack (that's us). You can choose to automatically donate your items if they do not sell (initial at the bottom). Formals must be picked up June 1st and cocktails must be picked up by November 1st. If they are not picked up by that date they will be property of Back On The Rack.
- \* It is the Consignor's responsibility to know when your items expire. Back On The Rack does not contact Consignor to notify them of account status. We ask that you give a 24 hour notice of when you would like to pick up your items, so we can have them ready for you.
- \* We will print checks at the end of every month; we promise. Minimum payout is \$27. Under \$27 will be issued as store credit. If you use your store credit you will receive 10% off your total purchase. Back On The Rack does offer a 30 day layaway. If your item(s) is placed on layaway you will receive payment once the layaway is completed.
- \* Back On The Rack will take exceptional care of the garments you consign; however, merchandise is left at your own risk. We are not liable for loss of garments due to fire, theft, vandalism or natural disaster or for in store damage. If any items are found damaged after inspection, they will be donated or sold at a discounted price.
- \* Please do not be offended if we cannot accept some of your items. We don't want to waste our time and yours by accepting items that won't sell. Drop and Run customers: You will have 10 days to pick up unwanted items before they become property of Back On The Rack.
- \* Back On The Rack will evaluate and price the items. Our main goal is to get the most money for both of us and we will do our best to reach this goal. Unless specifically stated herein, the final selling price is solely at the discretion of Back On The Rack.
